Maria, I wanted to let you know that I forwarded this on to Jennifer Branton and Clay James for their review as well. I did have a couple of comments regarding the submittal:

- 1. The plans show sharrows in the shoulder area. Sharrows are only supposed to be painted in areas where bicycles share lanes with cars, so they should not be recommended on the shoulders.
- 2. If a pedestrian sidewalk is proposed along the edge of the shoulder, what is the required offset for a 55mph roadway?
- 3. Has any study been done regarding the proposed bike crossing on sheet 3c?
- 4. Sheet 3d shows the path crossing the railroad tracks. Have they contacted the railroad about requirements and permission?
